19 Days of Child Abuse Prevention Results

The Child Advocacy Center participated in the 19 Days of Child Abuse Prevention Campaign November 1st-19th. The goal of the 19 Days of Child Abuse Prevention was to increase commitment, activities and education, and to mobilize communities throughout the world around child abuse prevention. This year the Child Advocacy Center participated with a community outreach campaign, No-Sew Blanket Frenzy Competition and Champion for Children Awards.

The results of the No-Sew Blanket Frenzy included over 200 blankets donated to the Child Advocacy Center from various organizations including: Alma O. Easom Elementary, Berean Baptist Church, Child Advocacy Center Staff, Fayetteville Area Youth for Christ, Fayetteville Technical Community College Criminal Justice Department, Lafayette Baptist Church, Kathy and Miranda Lee, St. James Lutheran, TRP Sumner and BB&T Now Truist. Children that come to the Child Advocacy Center receive a no-sew fleece blanket made by volunteers throughout our community. The need for these blankets is always a high priority as the children love to receive them. We call them "comfort" blankets as they provide a sense of comfort for the child as they leave the CAC.

The Child Advocacy Center also hosted *Story Time* for preschoolers across our community for childcare centers in Cumberland County, Ft. Bragg, and surrounding counties. Pre-recorded stories were uploaded for each of the 19 days and were

posted on our Facebook, Instagram and Youtube pages as well as being distributed electronically to our Partners in Prevention and local daycare centers. 2,000 backpacks were distributed to 20 daycare centers including Building Blocks of Hope Mills, Raeford, and Cameron, Head Start, Kinder Care on Fort Bragg Road and Snyder Preschool. Each backpack had a book on body safety, parentchild activity books and an informational packet for parents.

We also accepted multiple nominations for the annual Champion for Children Awards in the following categories: Agency/Group, Professional and Volunteer. Each person or agency that was nominated demonstrates what it means to go above and beyond in the fight against child abuse and neglect in our community. The 2020 recipients are Agency/Group -Cumberland County Sheriff's Office Special Victims Unit, Professional—Mr. Justin Mitchell, Deputy Garrison Commander of Ft. Bragg and the C. Frank Pierce Volunteer Award—Ms. Jackie O'Donnell, CAC Volunteer. We appreciate their efforts to ensure that each child in our community can grow up in a safe and nurturing community. The 19 Days Campaign serves as a reminder that there is something every person can do to prevent child abuse. Champion for Children Awards

Agency/Group Award: Cumberland County Sheriff's Office Special Victims Unit

The SVU Unit works in the community with collaborative efforts to ensure the safety and well-being of all children in Cumberland County. This unit made of up of instructors, volunteers and advocates serve the most vulnerable victims in our community. The unit is passionate about fighting for the children and their rights every single day. 2019 brought lots of changes for the Sheriff's office but they adapted and overcame for the children in the community. This unity is made up of professionals who are also parents. They fight for the children daily. They are Champions for Children.

Professional Award: Mr. Justin Mitchell, Deputy Garrison Commander

Mr. Mitchell works closely with Family Advocacy Program, Military Police, other first responders, Chaplains, childcares, and many more on the Ft. Bragg installation to ensure the safety and well being of all children and families. At the beginning of Covid-19, he mobilized the Army Community Services team to call each resident of the 6,151 on post homes to check on their welfare. This took place not only once but four times during the pandemic. 
caring efforts. He regularly takes time to check on staff members and lets them know he appreciates them and what they are doing for military families.

January Human Trafficking Awareness Month

The Polaris Project defines Human Trafficking as the business of stealing freedom for profit. Additional information on Human Trafficking includes:

- Traffickers often trick and physically force victims into selling sex.
- Manipulation and/or threats happen to force working in inhumane, illegal or unacceptable conditions.
- Trafficking is a multi-billion-dollar industry that denies freedom to 24.9 million people around the world.
- Sex trafficking is defined as a crime of using force, fraud or coercion to induce another individual to sell sex. Common types include escort services, pornography, illicit massage businesses, brothels, and outdoor solicitation.
- Labor trafficking is the crime of using force, fraud or coercion to induce another individual to work or provide service. Some types include agriculture, domestic work, restaurants, cleaning services, and carnivals.

The Child Advocacy Center will be hosting a Human Trafficking event on January 26, 2021, featuring guest speaker, Jeanne L. Allert, of Baltimore Maryland. Ms. Allert has been advancing residential care for victims of domestic sex trafficking since 2007. She created The Samaritan Women, a long-term restorative care program based in Maryland that serves trafficking victims from across the country. The Samaritan Women grew to a 5-phase program with three homes, an on-site schoolhouse and vocational training program.

Ms. Allert will host two seminars on the with the Child Advocacy Center.

The first private event will be from 1:00 pm – 4:00pm on "Victimology" and will be open for Multi-Disciplinary Team members. The second public event will be from 6:00 pm – 8:00 pm she will include a presentation on "Domestic Sex Trafficking in America". 

What We Do

A Place of Healing and Hope: Joining hands with community agencies, the Child Advocacy Center (CAC) offers a safe and child-friendly place to interview, investigate and provide support for child victims of abuse. The CAC also provides prevention education for parents, professionals and agencies in our community. We look to a future where all children live in a safe and nurturing environment free from abuse.

During FY 2020, the Child Advocacy Center received 876 cases of reported child abuse, a 20% increase from the past year. 1,181 adults received child abuse prevention training through programs offered by the CAC, including Stewards of Children, Recognizing & Reporting Child Abuse, Resilience and Chosen (Domestic Minor Sex Trafficking Education). 494 forensic interviews were conducted at the center, a 22% increase from the past fiscal year. 474 families received Victim Family Advocate services, providing direct aid as well as assisting them in accessing needed resources, an 18% increase from the previous fiscal year.
