A child-friendly, compassionate, and safe refuge - that is what the Child Advocacy Center means to hundreds of child victims of abuse in Cumberland County. Thanks to your generosity, the Child Advocacy Center has been here for 29 years as a beacon of hope, help and healing for children and their families as they chart the turbulent and difficult waters of disclosure, investigation, and prosecution of child abuse. During this past year, the Child Advocacy Center has continued to fulfill its mission of protecting children and stopping abuse. During FY 22, 808 cases of suspected child abuse were received by the Child Advocacy Center, 67% were female, and 30% were less than 7 years old. 569 cases were referred for forensic interviews, 612 victims received services with 499 being new victims who received services for the first time, 1470 people were provided child abuse prevention/awareness education and 800 children received body safety books. 877 individual counseling appointments were provided to 127 child abuse victims and 10 girls, and 10 boys participated in year-long group empowerment classes.

It is our hope, and the hope of the children served by the Child Advocacy Center that prevention and intervention of child abuse remains one of your top charitable-giving priorities. 

In January, the focus is on the impact of child trafficking both labor and sexual. Each of us has a role to play in helping to be the voice of children who are traumatized by many different forms of child maltreatment. Here are some of the Signs of Human Trafficking:

- · Appearing malnourished
- Showing signs of physical injuries and abuse
- Avoiding eye contact, social interaction, and authority figures/law enforcement
- Seeming to adhere to scripted or rehearsed responses in social interaction
- Lacking official identification documents

- Appearing destitute/lacking personal possessions
- Working excessively long hours
- Living at place of employment
- Checking into hotels/motels with older males, and referring to those males as boyfriend or "daddy," which is often street slang for pimp
- Poor physical or dental health
- Tattoos/ branding on the neck and/or lower back
- Untreated sexually transmitted diseases
- Small children serving in a family restaurant
- Security measures that appear to keep people inside an establishment barbed wire inside of a fence, bars covering the insides of windows
- Not allowing people to go into public alone, or speak for themselves

The Greater Exchange Club of Fayetteville sponsored 19 Days of Prevention which kicked off on November 4 with a Prevention Luncheon at the Kiwanis Recreation Center. Lilly, a survivor-leader in the Human Trafficking movement used her lived experience to educate and support our community by advocating for change. Plaques were presented to 14 new and renewing Partners in Prevention. These are organizations whose members have taken the Darkness to Light – Stewards of Children Child Sexual Abuse Training. Body Safety classes were provided to local childcare and Headstart Centers. The 19 days culminated with the announcement of the winners of the 2022 youth art contest "Showing kindness to your neighbor" sponsored by the Fayetteville-Cumberland County Arts Council, the Child Advocacy Center, and the Greater Exchange Club of Fayetteville. In addition to creating an original piece of art the contestants also had to write a 25–200-word essay that explained how the artwork represented kindness toward their neighbor. The reception was held at the Arts Council with remarks from Robert Pinson, Interim President and CEO of the Arts Council and Freddy Rivera, President of the Greater Fayetteville Exchange Club.

What We Do

A Place of Healing and Hope: Joining hands with community agencies, the Child Advocacy Center (CAC) offers a safe and child-friendly place to interview, investigate and provide support for child victims of abuse. The CAC also provides prevention education for parents, professionals, and agencies in our community. We look to a future where all children live in a safe and nurturing environment free from abuse.

During FY 2022, the Child Advocacy Center received 808 cases of reported child abuse. 467 forensic interviews were conducted at the center. 612 families received Victim Family Advocate services, providing direct aid as well as assisting them in accessing needed resources. 127 children attended individual counseling and 20 children participated in group counseling. 1470 people received child abuse prevention and awareness education. Volunteers contributed 1464 hours of service to the CAC. For additional information, please visit CACFayNC.org.
