## **BE THEIR VOICE: BREAKING THE SILENCE TO STOP HUMAN TRAFFICKING**

Human trafficking in America is a growing business. The Blue Campaign, which falls under the U.S. Department of Homeland Security, reports that 77% of all victims are subjected to forced labor, while 23% are victims of sex trafficking. Within sex trafficking cases, 78% of victims are women and girls, and 22% are men and boys.

The Blue Campaign also notes that there are no fully reliable estimates that accurately reflect the scope of human trafficking in the United States. However, cases have been reported in all 50 states, the District of Columbia, on Tribal lands, and within U.S. territories.

“Every two minutes, a child is sold into trafficking,” according to an April 2024 article published by Safe House Project, an anti-human trafficking organization. The report further states that more than 300,000 American children have fallen victim to the heinous crime of commercial sexual exploitation. On average, these victims are held in captivity for 23.4 months before they escape, are released, or tragically lose their lives.

According to the Blue Campaign, sex trafficking is defined as the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a person for the purpose of a commercial sex act, in which the act is induced by force, fraud, or coercion, or in which the person induced to perform such an act has not attained 18 years of age.

Safe House Project states that there are more people living in slavery today than at any other point in history. We join with other like-minded organizations to bring greater awareness and education to this issue. Through these efforts, we aim to help survivors access safe housing, emergency services, and long-term support.


## A SUCCESSFUL DAY ON THE COURSE FOR A POWERFUL CAUSE

## WHAT WE DO

*A Place of Healing and Hope: Joining hands with community partners, the Child Advocacy Center (CAC) offers a safe and child-friendly place to interview, investigate and provide support for child victims of abuse. The CAC also provides prevention education for parents, professionals, and agencies in our community. We look to a future where all children live in a safe and nurturing environment free from abuse.*

During FY 2025, the Child Advocacy Center made a meaningful impact in our community by providing 538 forensic interviews and offering Victim Family Advocate services to 524 families, ensuring they received direct aid and access to critical resources. A total of 103 children participated in individual counseling and 33 children took part in group counseling sessions, while 956 community members attended child abuse prevention and awareness education programs. Volunteers gave an incredible 1,722 hours of service, and our therapy dogs and their handlers brought comfort through 47 visits. Together, these efforts reflect the CAC's ongoing commitment to protecting children, supporting families, and raising awareness.
